#### REPRESENTATIONS

Mare owner hereby represents that all applicable mare and personal information is true, complete and correct. This contract is not transferable to any other mare other than the one approved and accepted by owner of stallion.

#### CONDITIONS FOR ACCEPTANCE FOR MARES TO BE BRED

Mare owner certifies that the mare is breedable and free of infectious diseases. If there are any questions regarding the breedablility and infectious disease status, stallion owner can request a veterinary inspection at mare owner's cost. If mares other than AQHA or APHA are accepted, mare owner may pay for stallion to be registered in that breed's registry. Mare owner agrees to have the mare pregnancy tested within 55 days after the date of breeding and provide that information in writing to stallion owner within two weeks of the test. Failure to provide said information will waive the live foal guarantee.

#### **BREEDING LOCATION**

Mare owner is responsible for transporting the mare to South Side Equine Hospital or Nelson Cutting Horses for breeding. Boarding and care costs are the responsibility of the mare owner.

## LIVE FOAL GUARANTEE

Owner of the stallion gives a live foal guarantee for up to one year after conception whereby, stallion owner will provide for a period of one year after initial breeding a rebreeding at no additional stallion fees. Rebreeding will be the sole and exclusive remedy under the live foal guarantee and there will be no consequential damages. For the purposes of the agreement, a live foal shall be one that stands and nurses without assistance, as is generally recognized in standard veterinary practice. Failure to produce a live foal shall be documented by a written statement from a licensed veterinarian within two weeks from death. Failure to provide the written statement waives the live foal guarantee. It being expressly understood that in the event of any re-breeding of the mare the mare owner shall be responsible for any additional veterinary care and boarding fees.

#### **BREEDING CERTIFICATES**

Breeding Certificates, as necessary for the registrations of the offspring will be given to mare owner within a few weeks of the mare foaling, provided that all fees and expenses incurred hereunder have been paid in full by mare owner.

#### **BOOKING FEE**

Upon payment of \$250 booking fee by mare owner to the stallion owner, which shall be non-refundable whatsoever, the stallion owner agrees to reserve for the mare owner one season breeding to Little Royal Boon for the services of the mare. The normal breeding season will be March 1<sup>st</sup> until August 1<sup>st</sup>. Mare owner agrees to utilize semen from Little Royal Boon only for breeding the mare named in this contract.

#### **BREEDING FEE**

Mare owner shall pay to the owner of the stallion a fee in the amount of \$1,000. The \$250 booking fee will be applied to the stallion fee upon breeding.

#### ADDITIONAL FEES

Mare owner will be responsible for all veterinary care and board fees. If mare does not settle on the first breeding, there will be additional applicable veterinary charges for 2<sup>nd</sup> or 3<sup>rd</sup> tries.

#### **REFUNDS**

The only fees that are refundable under this agreement are the breeding fees. They are only refundable should Little Royal Boon die or be unfit to breed for any reason. If the mare is to be re-bred as provided for herein, and the mare owner fails to deliver her for breeding then any and all fees paid shall not be refundable and this contract is hereby cancelled.

#### **WARRANTIES**

Other than as set forth herein, stallion owner makes no warranties, either express or implied, with regard to conception, live foal, or health or well-being of mare or foal.

#### WAIVER OF LIABILITY

Ron Yockim and Nelson Cutting Horses, its agents, or employees shall not be liable for any sickness, disease, death or injury which may be suffered by the mare, or any foal of the mare, or for any other cause of action whatsoever arising out of or in any way connected with the breeding of the mare. Mare owner understands that all risks connected with breeding to the mare and any foal that may be born to the mare as a consequence of breeding the mare to Little Royal Boon shall be solely the responsibility of the mare owner.
